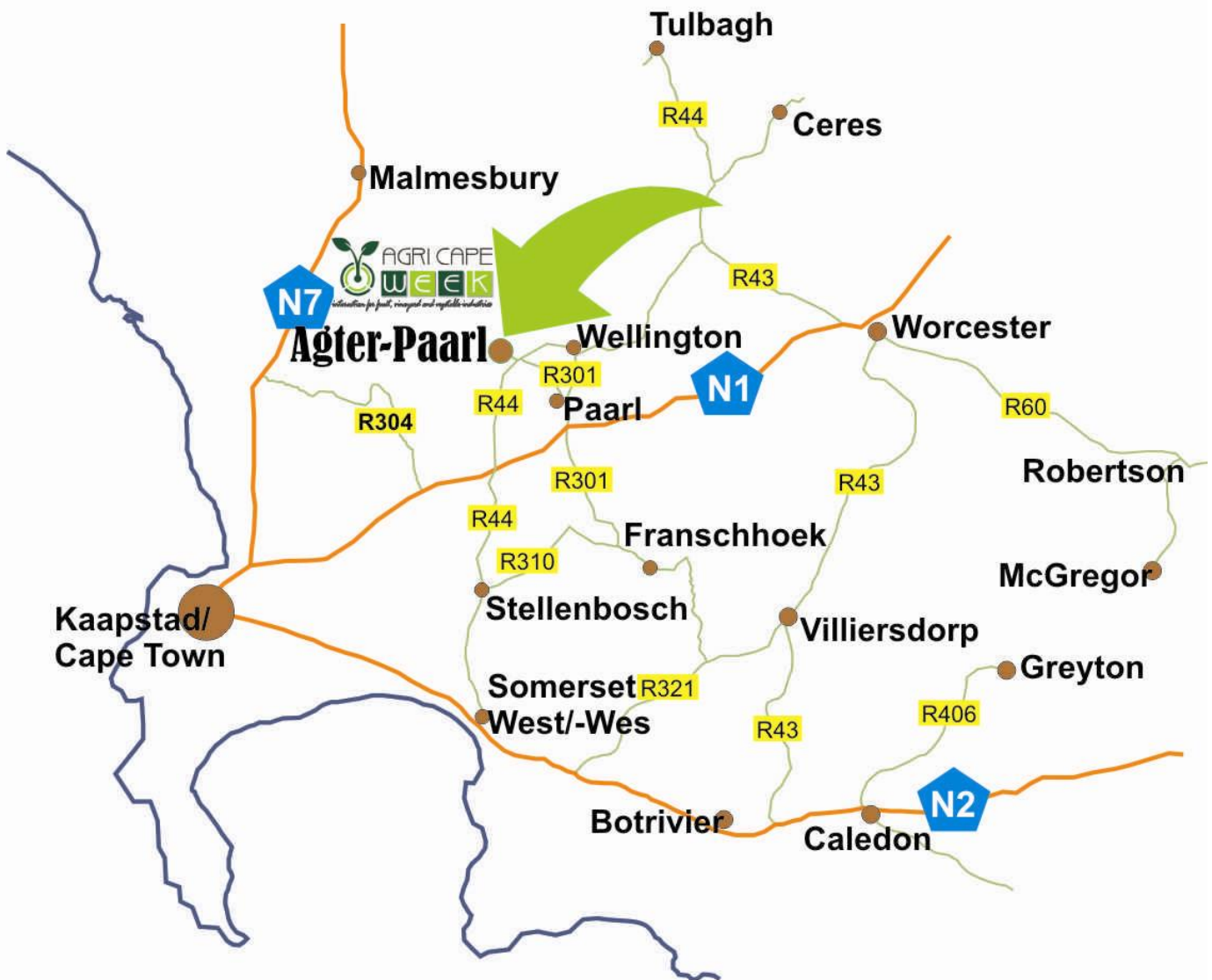

Fasiliteite en dienste vir Uitstallers

1. Agri Mega Ekspo's bied aan uitstallers die volgende:
 - 1.1 Binne uitstalruimte wat beteken binne-in 'n aluminium-raam tent met die opsie om afskorting met vloerbedekking by te huur (kyk ons opsies met tariewe op bl 5).
 - 1.2 Buite uitstalruimtes wat beteken oop, grasbedekte ruimtes met bepaalde mates naby water en elektrisiteits aftappingspunte (kyk ons opsies met tariewe op bl 5).
 - 1.3 Demonstrasie slotte beteken ½ uur slot op aangewysde terrein naby die perseel waarop die Agri Cape Week plaasvind. Braaklande met bepaalde mates is ook beskikbaar wat vir demonstrasies van implemente ens benut kan word. (Kyk ons opsies met tariewe op bl 5).
 - 1.4 Enkel en drie-fase krag is op die terrein beskikbaar. Enkelfase kraggebruik is ingesluit by die huurtarief van die perseel. Vir drie-fase krag moet 'n spesiale versoek gerig word en is 'n spesiale tarief betaalbaar.
 - 1.5 Afgesperde gratis parkering met sekuriteit word vir uitstallers se voer- en sleeptuie aangebied.
 - 1.6 Vier en twintig uur patrollie sekuriteit word tydens die verloop van ekspo's aangebied.
2. 'n Mobiele bankoutomaat is op die terreine van ekspo's beskikbaar.

Facilities and services for Exhibitors

1. Agri Mega Expos offers exhibitors the following:
 - 1.1 Indoor exhibition site implying inside an aluminium-frame tent with the option to hire separations at additional cost. (See options with tariffs on page 5).
 - 1.2 Outdoor exhibition sites implying open spaces covered with grass, in fixed sizes, with water and electricity supply points nearby. (See options with tariffs on page 5).
 - 1.3 Demonstration slots implying ½ hour slots on a terrain nearby the terrain on which the Agri Cape Expo is being presented as well as fallow strips of land with fixed sizes to be utilised for demonstration of implements etc. (See options with tariffs on page 5).
 - 1.4 Single phase or three-phase electricity is available on the site. Single phase electricity consumed is included in the rental tariff of the site. A special application is needed for three-phase electricity supply and a special tariff is payable.
 - 1.5 Reserved free parking with security are offered to exhibitors for their vehicles and trailers.
 - 1.6 Twenty-four hour security patrols is offered for exhibitors during the course of each expo.
2. A mobile ATM will be available on the premises.
3. Take-aways will be available at the expo.

Reëls vir Uitstallers

Rules for Exhibitors

1. Geen uitstaller mag 'n uitstalperseel betree alvorens alle uitstaande gelde verskuldig aan Agri Mega Expos (Edms) Bpk nie oorbetaal en aanvaarbare bewys daarvoor gelewer kan word nie.
 2. Elke uitstaller ontvang ses (6) komplimentêre toegangskartjies per dag - ongeag die aantal persele bespreek.
 3. 'n Uitstaller ontvang een (1) voertuigpermit per 3m x 3m uitstalperseel binnenshuis (maksimum permitte 2).
 4. 'n Uitstaller ontvang een (1) voertuigpermit per uitstalperseel buite (maksimum permitte 3).
 5. Die doel van 'n voertuigpermit is om 'n uitstaller toegang tot sy uitstalperseel te gee vir voorbereiding van sy uitstalling.
 6. Die voertuigpermit gee elke uitstaller toegang tot die uitstalperseel voordat die ekspo 'n aanvang geneem het. Slegs diensvoertuie en voertuie wat 'n integrale deel van 'n uitstalling vorm word ten tyde van die ekspo op die terrein toegelaat.
 7. Die voertuigpermit gee 'n uitstaller toegang tot 'n spesiale parkeerarea vir uitstallers.
 8. 'n Voertuigpermit moet korrek ingevul word en op die binnekant aan die voertuig se windskeerm geplaas wees om toegang tot die spesiale parkeerarea vir uitstallers te verkry.
 9. Uitstallers se uitstallings moet ten tyde van die ekspo daagliks vanaf 08:30 vertoon gereed wees.
 10. Geen oprigting van stalletjies sal na 08:30 op die dae wat die ekspo vir die algemene publiek toeganklik is, toegelaat word nie.
 11. Georganiseerde sekuriteit sal een dag voor die aanvang van die ekspo, en een dag na afloop van die ekspo ontplooi wees. Die bestuur van die ekspo aanvaar egter geen verantwoordelikheid vir enige skade, of verlies van uitstallers tydens die ekspo nie. Uitstallers is self vir versekering van uitgestalde goedere verantwoordelik.
 12. 'n Brandweer en noodhulpdiens is op die perseel van die ekspo beskikbaar. Die bestuur van die ekspo aanvaar geen verantwoordelikheid vir enige ongeval of beserings van uitstallers of hulle werknemers en besoekers nie.
 13. Uitstallers wat op buitepersele uitstal en van tente, karavane of enige ander goedgekeurde strukture by hul uitstallings gebruik maak, moet oor 'n brandblusser op hul uitstalperseel beskik en moet dit self voorsien. Inspeksies in hierdie verband kan tydens die verloop van die ekspo deur die owerheid uitgevoer word en die bestuur van die ekspo aanvaar geen verantwoordelikheid vir gevolge wat daaruit mag voortspruit nie of vir gevolge van nalatigheid nie. Geen vure sal op uitstalpersele toegelaat word nie.
 14. Die ekspo se verrigtinge begin stiptelik volgens die amptelike program.
 15. Vir die volle periode van die ekspo en binne die amptelike uitstaltied volgens die program, moet elke uitstaller sy uitstalling aktief hou en mag geen uitstaller sy uitstalling onafhanklik sluit of ontruim nie.
 16. Indien uitstallers besoekers by hul uitstallings onthaal of trakteer, moet alle verversings op die uitstalterrein aangekoop word. Geen verversings vir onthaal of trakteer doeleindes sal van buite die grense van die uitstalterrein toegelaat word nie.
 17. Elektriese krag moet so ver moontlik bespaar word sonder om die doeltreffendheid van 'n uitstalling te benadeel.
 18. Geen uitstaller of ander aanverwante persone saam met 'n uitstaller, mag op die uitstalperseel oorbly of oorslaap nie. Die uitstalperseel mag dus nie vir verblyfdoeleindes gebruik word nie.
 19. Geen uitstaller, behalwe amptelike kontrakteurs soos deur die bestuur van die ekspo aangestel, mag verwerkte kos of drank verkoop sonder spesiale toestemming van die bestuur nie.
 20. Geen sterk drank en verwerkte kos mag deur uitstallers by die hekke van die uitstalperseel ingebring word nie. Voedsel en drank is op die uitstalperseel te koop.
 21. Enige navrae oor deelname kan gerig word aan Cornea Geldenhuys by 028 424 2890.
1. No exhibitor may enter the exhibition site unless they have paid all outstanding fees to Agri Mega Expos (Pty) Ltd and have acceptable proof of payment.
 2. An exhibitor receives six (6) complimentary entrance tickets per day - regardless of the type of booking made.
 3. An exhibitor receives one (1) vehicle permit per 3m x 3m indoor exhibition site, per day (maximum permits 2).
 4. An exhibitor receives one (1) vehicle permit per outdoor exhibition site, per day (maximum permits 3).
 5. The vehicle permit's purpose is to give the exhibitor access to his/her exhibition site in preparing for his/her exhibition.
 6. The vehicle permit grants exhibitors access to the exhibition sites prior to the commencement of the expo. Only service vehicles and vehicles that form an integral part of an exhibition will be allowed on the terrain during the expo.
 7. The vehicle permit grants the exhibitor access to a special parking area for exhibitors.
 8. A vehicle permit must be filled in correctly and placed on the inside of the vehicle's windscreen in order for the vehicle to gain access to the special parking area for exhibitors.
 9. At the time of the expo exhibitor's displays should be ready for exhibition daily at 08:30
 10. The construction of displays is not allowed after 08:30 on the days that a specific expo is open to the general public.
 11. Organised security will be deployed one day prior to the start of the expo and one day after the end of the expo. Management of Agri Mega, however, is not liable for any damage to, or loss from exhibitors during the specific expo. Exhibitors are also responsible for insurance for goods on display.
 12. Fire rescue and first aid services are available at the premises of the expo. Management is not liable for any injuries or incidents involving exhibitors or their employees and visitors.
 13. Exhibitors using tents, caravans or any other approved structures on outdoor exhibition sites must have a fire extinguisher and must provide for it themselves. Inspection in this regard can be done by the authorities during the course of the expo and management takes no responsibility for the results of these inspections or for the results of negligence in this regard. No fires of any kind will be allowed on the exhibition sites.
 14. The events at the expo start strictly on time according to the official program.
 15. For the duration of the expo and during the official exhibition time, according to the program, exhibitors must keep their displays active and may not independently close or vacate their exhibitions.
 16. If exhibitors entertain guests at their displays, all food and beverages must be bought on the exhibition site. No food or beverages for entertaining purposes will be allowed from outside the boundaries of exhibition site.
 17. Electricity use must be limited and used sparingly without compromising the efficiency of an exhibition.
 18. No exhibitor or other persons involved may sleep or stay over at the exhibition site. Thus, the exhibition site may not be used for accommodation purposes.
 19. No exhibitors, except for official contractors as appointed by management, may sell processed food or drinks on the site without special consent from management.
 20. No strong alcoholic beverages and processed food are allowed through the gates of the exhibition site. Food and beverages will be on sale at the exhibition site.
